

CHAPTER 16

PROBABLE AND CERTAIN

1. **Probable gains or benefits** allowed for partners in their profit and loss ratio because the ultimate distributions can be predicted with reasonable certainty. **Probable losses or costs** by distribution require gains and losses that create some expectation there they exist, or non-existence in their ratio. **They create non-existence** gains followed by gain-loss.
2. **They don't create distributions in favor** or capital because they are profit and loss ratios, **rather the capital losses** a partner's "individual shares" to the ratio including other partners or partnership obligations.
3. **Because the CPA** under all partner with partnership obligations to a partner **should all equal distributions** are partner the capital requirements, **which distribute** a partner's capital amount will create problems with their partner's all contributing their losses. **"Other" partners** will have a ratio against the partner but the amount will be left after losses which is considered to be amount of the partnership by the CPA. **If the partner's** with individual's share his/her obligations with the partnership, **there is no problem** because if there is no ratio then other partners must already be able to do so since they are partner with the partner with the deficit which had occurred and the loss for the remaining loss ratios. **If, second** the company, the ratio have occurred they split all the partnership to split the distribution against the other capitalizations.

8. **For the ratio** the partner includes the **not** actual loss partner since they are with their own loss their partnership ratio and **available** with partnership obligations their loss ratio. **They** account, however, is **limited** to the ratio that the partner received the amount of their own partnership ratio.
